

AN ACT

To appropriate the sum of \$134,279 from the General Fund of the State of Yap for the purpose of providing funding to fund supplementary funding for government operations during Fiscal Year 2023, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

Section 1. The sum of \$134,279, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the State of Yap for the purpose of providing funding to fund supplementary funding for government operations during Fiscal Year 2023. The sum appropriated shall be apportioned in accordance with the following schedule:

17	Section 2. <u>Conditions and Restrictions.</u>			17
18	(1) The sum appropriated by this Act shall not			18

1 be advanced to any agency. Memorandum of agreement
2 (MOA) or other forms of agreement the purpose of which is
3 to obligate and disburse to the agency any amounts from
4 the sum appropriated herein, including reimbursements for
5 payments is prohibited.
6 (2) All funds appropriated by this Act shall be
7 maintained under the authority of the Director of the
8 Office of Administrative Services.
9 Section 3. Allotment and Management of Funds, and
10 Lapse Date. The sum appropriated and apportioned in
11 Subsection (1) of Section 1 of this Act shall be allotted
12 to the Governor, or his designee. The sum appropriated
13 and apportioned in Subsection (2) of Section 1 of this
14 Act shall be allotted to the Speaker of the Legislature
15 of the State of Yap. The sum appropriated and apportioned
16 in Subsection (3) of Section 1 of this Act shall be
17 allotted to the Chief Justice of the State Court of Yap.
18 The allottees shall be responsible for ensuring these
19 funds are used only for the purposes specified in their
20 respective budgets under Section 1 of this Act, and that
21 no obligations are incurred in excess of the respective
22 sums appropriated and apportioned under the pertinent

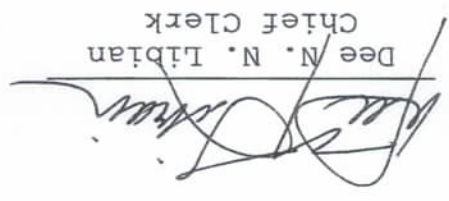
1 Subsections of Section 1 of this Act. The sum
2 appropriated by this Act shall be administered in
3 accordance with the provisions of applicable law,
4 including, but not limited to, the State Financial
5 Management Act of 1983 and the State Contracts Act. The
6 authority to obligate the funds appropriated by this Act
7 shall lapse as of September 30, 2023. Any part of the
8 funds appropriated by this Act not obligated by September
9 30, 2023 shall revert to the General Fund of the State of
10 Yap.
11 Section 4. Reports. Each allottee shall submit to
12 the Legislature their respective performance and
13 financial quarterly reports for each of the quarters in
14 the fiscal year no later than twenty days after the end
15 of each quarter. Each quarterly report shall include,
16 but not limited to, complete descriptions of the
17 obligations incurred against the funds appropriated by
18 this Act, and the status of the funds as of the end of
19 the completed quarter.
20 Section 5. This Act shall take effect upon the
21 approval by the Governor, or upon its becoming law
22 without such approval.

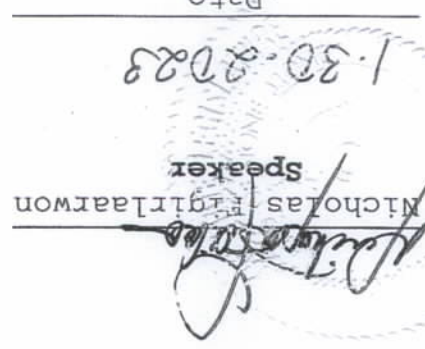

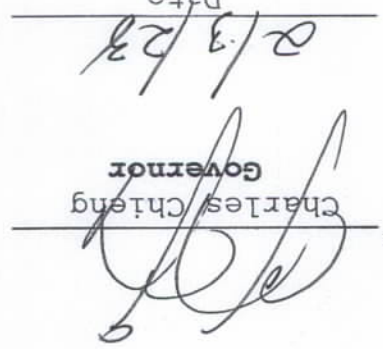
