## AN ACT

To appropriate the sum of \$42,615.25 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for Department of Health Services programs during Fiscal Year 2024, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$42,615.25, or so much  
2       thereof as may be necessary, is hereby appropriated from  
3       the Special Revenue Fund of the State of Yap for the  
4       purpose of providing funding to fund Department of Health  
5       Services programs during Fiscal Year 2024. The sum  
6       appropriated shall be deemed from United States Federal  
7       Grants awarded as follow:

8 (1) FY2024 SSDI Program \$ 1,580,251

## 15 Section 2. Conditions and Restrictions

3 (2) The sum appropriated by this Act shall not  
4 be advanced to the agency. Memorandum of agreement (MOA)  
5 or other forms of agreement the purpose of which is to  
6 obligate and disburse to the agency any amounts from the  
7 sum appropriated herein, including reimbursements for  
8 payments is prohibited.

9 (3) All funds appropriated by this Act shall  
10 be maintained under the authority of the Director of the  
11 Office of Administrative Services.

12 Section 3. Allotment and Management of Funds, and  
13 Lapse Date. The sum appropriated by this Act shall be  
14 allotted to the Governor who shall be responsible for  
15 ensuring these funds are used only for the purposes  
16 specified under Section 1 of this Act. The sum  
17 appropriated by this Act shall be administered in  
18 accordance with the provisions of applicable law,  
19 including, but not limited to, the State Financial  
20 Management Act of 1983 and the State Contracts Act. The  
21 authority to obligate the funds appropriated by this Act  
22 shall lapse as of the respective dates as specified under

1       each grant item under Section 1 of this Act, and any part  
2       of this appropriation not obligated as of the date  
3       specified for each grant under Section 1 shall revert to  
4       the Special Revenue Fund of the State of Yap.

5           Section 4. Reports. The Governor shall submit to  
6       the Legislature the performance and financial quarterly  
7       reports for each quarter in each fiscal year no later  
8       than twenty days after the end of each quarter. Each  
9       quarterly report shall include, but not limited to,  
10       complete descriptions of the obligations incurred against  
11       the funds appropriated by this Act, and the status of  
12       the Funds as of the end of the completed quarter.

13       Section 5. This Act shall take effect upon its  
14       approval by the Governor, or upon its becoming law  
15       without such approval.






