YAP STATE LAW NO. 11-101

THIRD REGULAR SESSION, 2025

AN ACT

To appropriate the sum of \$654,778 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for a public health program and Waab Community Health Center with the Department of Health Services during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$654,778, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 Special Revenue Fund of the State of Yap for the purpose
4 of providing funding to fund a public health program and
5 Waab Community Health Center with the Department of
6 Health Services during Fiscal Year 2025. The sum
7 appropriated shall be deemed from United States Federal
8 Grants awarded for health programs as follow:

9 (1) Waab Community Health Center
10 Operation Program..... \$ 638,778;
11 and
12 (Grant No. 5 H80CS06653-20-00,
13 expiring on December 31, 2025)
14 (2) FY2025 OPIOD Response (SOR)
15 Program \$ 16,000.
16 (Grant No. 1H79TI087919-01
17 6 NU52PS910242-02-01, expiring on
18 September 29, 2025)

1 Section 2. Conditions and Restrictions.

2 (1) Funds appropriated by this Act shall not be
3 available for obligation for their planned uses by the
4 agency until the respective grant cash amounts have been
5 drawn down by the State and are deposited in their
6 respective State accounts and available for disbursement.

7 (2) The sum appropriated by this Act shall not
8 be advanced to the agency. Memorandum of agreement (MOA)
9 or other forms of agreement the purpose of which is to
10 obligate and disburse to the agency any amounts from the
11 sum appropriated herein, including reimbursements for
12 payments is prohibited.

13 (3) All funds appropriated by this Act shall
14 be maintained under the authority of the Director of the
15 Office of Administrative Services.

16 Section 3. Allotment and Management of Funds, and
17 Lapse Date. The sum appropriated by this Act shall be
18 allotted to the Governor who shall be responsible for
19 ensuring these funds are used only for the purposes
20 specified under Section 1 of this Act. The sum
21 appropriated by this Act shall be administered in
22 accordance with the provisions of applicable law,

1 including, but not limited to, the State Financial
2 Management Act of 1983 and the State Contracts Act. The
3 authority to obligate the funds appropriated by this Act
4 shall lapse as of the respective dates as specified under
5 each grant item under Section 1 of this Act, and any part
6 of this appropriation not obligated as of the date
7 specified for each grant under Section 1 shall revert to
8 the Special Revenue Fund of the State of Yap.

9 Section 4. Reports. The Governor shall submit to
10 the Legislature the performance and financial quarterly
11 reports for each quarter in each fiscal year no later
12 than twenty days after the end of each quarter. Each
13 quarterly report shall include, but not limited to,
14 complete descriptions of the obligations incurred against
15 the funds appropriated by this Act, and the status of
16 the funds as of the end of the completed quarter.

17 Section 5. This Act shall take effect upon its
18 approval by the Governor, or upon its becoming law
19 without such approval.






