YAP STATE LAW NO. 11-102

THIRD REGULAR SESSION, 2025

AN ACT

To amend Yap State Law No. 11-29, by amending the Title and Section 1 to appropriate an additional sum of \$17,250 from the Special Revenue Fund of the State of Yap for the Department of Health Services programs during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap,

1 Section 1. The Title of Yap State Law No. 11-29 is
2 hereby amended to read as follows:

3 "To appropriate the sum of \$266,238 from the Special
4 Revenue Fund of the State of Yap for the purpose of
5 appropriating U.S. Federal grant funds awarded for
6 Department of Health programs during Fiscal Year 20245,
7 and for other purposes."

8 Section 2. Section 1 of Yap State Law No. 11-29 is
9 hereby amended to read as follows:

10 "Section 1. The sum of \$266,238, or so much thereof
11 as may be necessary, is hereby appropriated from the
12 Special Revenue Fund of the State of Yap for the purpose
13 of providing funding to fund Department of Health
14 Services programs during Fiscal Year 2025. The sum
15 appropriated shall be deemed from United States Federal
16 Grants awarded for health programs as follows:


3 Section 3. This Act shall take effect upon its
